## Miss Molly's Dog Policy

Thank you for choosing Miss Molly's Inn for your upcoming getaway! We look forward to meeting you and your well-behaved, friendly four-legged friend. Please note and adhere to the following policies so that you, your pet, and our other guests can all enjoy a relaxing and comfortable stay at our inn. You will be asked to sign a copy of this policy when you check in. If you have any questions about our policy prior to your arrival, please call us at 757-336-6686 to speak with Renata Murphy directly. We look forward to seeing you!

## **HOUSE RULES FOR PET OWNERS:**

A daily pet tariff of \$35 will be added to your room. Only our Bay Room can accommodate pets; please inform us before check-in if you will be traveling with a four legged friend. Dogs must be less than 35 pounds, unless previously discussed with the innkeeper. For everyone's comfort, we have a limit of 1 dog per room. Dogs must be well behaved and get along with humans and other canines (we have 2 dogs ourselves on the property).

Dogs should be always on a leash while on Miss Molly's house and grounds. Any damage done to rooms or other people on the premises by companion animals is the absolute responsibility of the pet's owner. Pets that cause any disturbance (e.g.: barking, scratching), may not be left unattended.

At check-in, pet owners will provide their cell phone number. If there is a disturbance while the guest is out of the room, we will call you and expect you to return to the inn within 15 minutes for the comfort of all our guests.

If you leave your dog in our room alone, your dog MUST BE IN A CRATE. Otherwise, we encourage you to reach out to our wonderful dog sitter, Anna Dove at 757-894-5114, she can bring your dog to our local dog park or take him or her on walks or to her home while you are out and about enjoying Chincoteague. Make sure to book her in advance and know that she will require your dog's shot records.

While visiting Chincoteague with your dog, its useful to know that dogs are not allowed on the Chincoteague National Wildlife Refuge, not even in your car. There are a few beaches on the mainland (20 to 30 minutes away) where you may bring your dog and 2 or 3 pet friendly restaurants where you may dine outside with your dog.

We ask that your dog not lie on our beds, if your companion animal is accustomed to lying on furniture such as beds, couches, etc., we ask that you bring blankets or sheets to cover those areas. If you need a blanket provided, just let us know.

Pets must not be bathed in Miss Molly's showers. Dirty and/or sandy pets may be bathed in the rear of the property using a garden hose & "dog towels" we provide. They must be completely dry before being returned to the room. Just ask!

We have small dog run on the side of our house you may use. Out of respect for other guests and our property, please don't forget to pick up the poop! We are happy to provide you with bags if you run out.

We reserve the right to terminate occupancy without refund if damage or disturbances or barking persists. The pet owner assumes all liability for the behavior of the pet. Your signature below affirms that you are the pet's owner, and you agree to indemnify and hold harmless Miss Molly's Inn, its owners and employees, from any claim, action, liability, or suit arising from any event related to or stemming from the pet's stay.
